#### 7. PUBLIC HEARING ON USE OF 2016 CBDG FUNDS AND POSSIBLE PROJECTS.

Mayor Isakson announced to opening of the first public hearing on the Town of Patagonia's proposed application for CBDG funding for 2016. The hearing commenced at 7:07 p.m.

Anticipated possible funding under the agreements with Santa Cruz County and the City of Nogales will be \$334,938.

Mr. Teel reported on the possible "phase Two Water system Project" which might include additional valve and fire hydrant replacement, replacement of leaking and deteriorated existing water mains (including Sheard Avenue) and replacement of water meters more than 20 years old. He indicated that he is currently working with the Town water system operators to identify all the items that need to be included.

Mr. Klein and Ms. Shafer spoke on the need to focus on upgrades to the existing infrastructure.

Vice-Mayor Wood spoke on the need to rebuild many of the streets andto include storm drainage and sidewalks as part of the work.

There was discussion of the possible extension of a water main out Harshaw Avenue to reach homes that are not presently served with public water.

Several comments were made concerning the need for upgrades and tree planting in the Town Park including the possible replacement of the water main therein.

Mayor Isakson raised the need for a street light for the pedestrian crossing at first avenue and Route 82 for school children
