

TOWN OF PATAGONIA
SPECIAL COUNCIL WORKSHOP MEETING WORKSHOP
DECEMBER 15, 2012
9:00 A .M.

1. CALL TO ORDER The Meeting was called to order by Mayor Isakson at 9:10 a.m. Members present were Mayor Isakson, Vice mayor Wood, Council members Gilbert and Quiroga. Staff present was Town Manager Teel and Town Attorney Masee. Absent, Council member Coleman.
2. FINAL REVIEW, DISCUSSION AND POSSIBLE RECOMMENDATION TO STAFF ON ATTORNEY'S DRAFT TO UPDATE AND AMEND CHAPTER FOURTEEN, PLANNING AND ZONING COMMITTEE, OF THE TOWN CODE OF THE TOWN OF PATAGONIA. The draft was reviewed and changes recommended to Mr. Masee for inclusion in a final version to be re-circulated to Council.
3. FINAL REVIEW, DISCUSSION AND POSSIBLE RECOMMENDATION TO STAFF ON ATTORNEY'S DRAFT TO UPDATE AND AMEND CHAPTER SEVEN, BUILDING, OF THE TOWN CODE OF THE TOWN OF PATAGONIA. The draft was reviewed and changes recommended to Mr. Masee for inclusion in a final version to be re-circulated to Council.

At this point Council moved to Item 7 on the agenda. Marshal Patterson joined the meeting and discussion

7. REVIEW, DISCUSSION AND POSSIBLE RECOMMENDATION TO STAFF TO UPDATE AND AMEND CHAPTER SIX, ANIMALS, OF THE TOWN CODE OF THE TOWN OF PATAGONIA. Marshal Patterson presented a number of draft recommendations and there was an extensive discussion. At the end of the discussion Marshal Patterson, Mr Teel and Mr Masee are to collaborate on preparing a new draft for review.

Marshal Patterson left at the end of this discussion.

4. REVIEW, DISCUSSION AND POSSIBLE RECOMMENDATION TO STAFF TO UPDATE AND AMEND CHAPTER THREE, ADMINISTRATION, OF THE TOWN CODE OF THE TOWN OF PATAGONIA. The draft article was reviewed and the Manager was instructed to prepare recommendations on the "purchasing item for inclusion in a new draft along with the other changes recommended. .
5. REVIEW, DISCUSSION AND POSSIBLE RECOMMENDATION TO STAFF TO UPDATE AND AMEND CHAPTER FOUR, POLICE/FIRE, OF THE TOWN CODE OF THE TOWN OF PATAGONIA. Mr. Masee had not completed the re-draft and this item was deferred to a future meeting.
6. REVIEW, DISCUSSION AND POSSIBLE RECOMMENDATION TO STAFF TO UPDATE AND AMEND CHAPTER FIVE, COURT OF THE TOWN CODE OF THE TOWN OF PATAGONIA. Mr. Masee reported on some case law suggesting that the term of the Municipal Judge should be 4 years instead of two and Council instructed him to include this in a revised draft.

7. FUTURE AGENDA ITEMS: AT THIS TIME THE COUNCIL MAY BRING FORTH TOPICS FOR FUTURE AGENDAS, AND IF PREVIOUSLY REJECTED BY THE MAYOR, THE COUNCIL MAY VOTE ON CODE WHETHER TO PLACE THAT ITEM ON A FUTURE AGENDA PURSUANT TO SECTION 2-5-5 OF THE CODE OF THE TOWN OF PATAGONIA, ARIZONA. THE COUNCIL MAY NOT DISCUSS, DELIBERATE OR TAKE ANY ACTION ON THE SUBSTANCE OF THE TOPICS OTHER THAN TO VOTE TO INCLUDE THEM ON A FUTURE AGENDA. A.R.S. § 38-431.02(H).

It was agreed to schedule the next workshop on January 12, 2013.
