

**TOWN OF PATAGONIA**  
**SPECIAL COUNCIL WORKSHOP MEETING MINUTES**  
**April 3 , 2013**  
**6:00 P .M.**

1. CALL TO ORDER Mayor Isakson called the meeting to order at 6:08 p.m.  
PRESENT; Mayor Isakson, Vice mayor Wood, Council Members Quiroga and Gilbert.  
ABSENT: Council member Coleman Mr. Coleman arrived at 6:55 p.m.  
STAFF: Town Attorney Masee, Town Manager Teel
  
2. REVIEW OF STAFF DRAFT, DISCUSSION AND POSSIBLE RECOMMENDATION TO STAFF TO UPDATE AND AMEND CHAPTER SIX, ANIMALS, OF THE TOWN CODE OF THE TOWN OF PATAGONIA. Mr. Masee's draft was reviewed and a few changes suggested. Mr. Masee will prepare a final draft for introduction at the council meeting on April 10 and possible public hearing on May 8.
  
3. REVIEW, DISCUSSION AND POSSIBLE RECOMMENDATION TO STAFF TO UPDATE AND AMEND CHAPTER EIGHT, BUSINESSES, OF THE TOWN CODE OF THE TOWN OF PATAGONIA Mr. Masee's draft was reviewed and further suggestions made for improvement.
  
4. REVIEW, DISCUSSION AND POSSIBLE RECOMMENDATION TO STAFF TO UPDATE AND AMEND CHAPTER NINE, HEALTH AND SANITATION, OF THE TOWN CODE OF THE TOWN OF PATAGONIA. Chapter 9 was reviewed and the principal changes are to be moving the fees to a resolution rather than in the ordinance and an updating of the language reflecting the Town Manager rather than clerk-treasurer as the administering official. There was concern expressed about container size and whether 30 gallon garbage cans are too small.
  
5. REVIEW, DISCUSSION AND POSSIBLE RECOMMENDATION TO STAFF TO UPDATE AND AMEND CHAPTER TEN, OFFENSES, OF THE TOWN CODE OF THE TOWN OF PATAGONIA. This chapter was reviewed and discussed, with particular focus on questions of noise enforcement.
  
6. REVIEW, DISCUSSION AND POSSIBLE RECOMMENDATION TO STAFF TO UPDATE ITEMS FOR DRAFT FISCAL YEAR 2014 BUDGET. Mr. Teel presented the latest draft on the budget and pointed out some potential future problem areas. He was given some items for additional research.
  
7. FUTURE AGENDA ITEMS: AT THIS TIME THE COUNCIL MAY BRING FORTH TOPICS FOR FUTURE AGENDAS, AND IF PREVIOUSLY REJECTED BY THE MAYOR, THE COUNCIL MAY VOTE ON CODE WHETHER TO PLACE THAT ITEM ON A FUTURE AGENDA PURSUANT TO SECTION 2-5-5 OF THE CODE OF THE TOWN OF PATAGONIA, ARIZONA. THE COUNCIL MAY NOT DISCUSS, DELIBERATE OR TAKE ANY ACTION ON THE SUBSTANCE OF THE TOPICS OTHER THAN TO VOTE TO INCLUDE THEM ON A FUTURE AGENDA. A.R.S. § 38-431.02(H). None
