1. CALL TO ORDER Mayor Isakson called the meeting to order at 6:00 P.M.

2. DISCUSSION AND POSSIBLE RECOMMENDATIONS TO STAFF ON DRAFT ORDINANCE PERTAINING TO OVERWEIGHT VEHICLES.

Mr. Massee described the new draft. He stated that it followed the Federal regulations pertaining to trucks and vehicle weight. There was a discussion of fees which Mr. Massee indicated would cover administrative costs, not provide a fund for road repairs. There were questions about what the design standards were for the Town streets compared to State and County Roads and Highways. It was requested that a map showing truck routes be part of the ordinance. There were discussions of the requirement for signage based on the restrictions.

Mr. Massee will continue his review of State and Federal Regulations and how they need to apply to any Town regulations. He will present an updated draft for consideration in 2-4 weeks.
