1. Mayor Isakson called the meeting to order at 6:00 p.m.

2. PRESENTATION, DISCUSSION AND POSSIBLE ACTION ON REPORT BY ALISON JONES, CLEAR CREEK ASSOCIATES ON RESULTS OF THE WIFA WATER STUDY

Ms. Jones and Mr. Carlson gave a power point presentation and conducted a discussion of the study they conducted of the characteristics of the Sonoita Creek aquifer in the vicinity of the town wells. They reported that the water bearing alluvium was larger and deeper than they had expected based on the general characteristics of the geology in the area. They reported that the town could extend their present wells or drill new ones up to nearly 300 feet in depth if needed due to dropping water levels. There was extensive public discussion of the significance of the study.

The discussion and their presentation ended 7:04 p.m.

The presentation was adjourned briefly and then called back to order by Mayor Isakson at 8:07 p.m.

3. DISCUSSIONS AND POSSIBLE RECOMMENDATIONS TO STAFF ON DRAFT AMENDMENTS TO TOWN CODE ARTICLE 11, ARTICLE 4, SECTIONS 4-1 THROUGH SECTION 4-8, VEHICLE WEIGHT AND NOISE RESTRICTIONS ON PUBLIC ROADS

Mr. Massee presented a brief discussion on the present Town Ordinance and its relationship to the present state statutes regarding vehicle weight and operation. He indicated that some additional "tweaking" was needed.

Marshal Paterson spoke regarding the problems of enforcement and the need for specific evidence in citing vehicles for being overweight.

There was public discussion and a number of suggestions for modifications to the town ordinance.
