

RESOLUTION 2016-04

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF PATAGONIA, ARIZONA APPROVING AND ESTABLISHING USER RATES AND CHARGES FOR THE TOWN'S POTABLE WATER AND SANITARY SEWER UTILITIES

WHEREAS, Chapter 12 of the Town Code requires the Council to set water and sanitary sewer user rates and charges by resolution, sufficient to allow the two utilities to operate without subsidies from the Town general fund; and

WHEREAS, the Town Manager has presented the Council with a water and sewer cost of operations and rate study showing the need to raise water and sewer revenues to maintain the same level of service; and

WHEREAS, the proposed user rates and service charges, set forth in the respective Water and Sewer Rate Tables, attached hereto as Exhibit A, appear sufficient to raise the revenues required to maintain current level of service without subsidies from the general fund; and

WHEREAS, published notice and a public hearing required by A.R.S. § 9-511.01 has been made and held.

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Council of the Town of Patagonia that the rates and charges set forth in the Water and Sewer Rate Tables, attached hereto as Exhibit A, are hereby approved and adopted.

BE IT FURTHER RESOLVED that the revised water and sewer user rates and charges shall be effective thirty days after adoption of this Resolution.
