CHARLEE FARLEY REQUESTED ACTION ON THE CAT ORDINANCE BECAUSE IT HAD BEEN TWO YEARS SINCE SHE HAD BEEN LOBBYING FOR IT. THE MAYOR RESPONDED ASKING TOWN MANAGER ROBINSON WHAT THE COUNCIL SCHEDULE LOOKED LIKE AND WHEN WE COULD SCHEDULE A STUDY SESSION TO ADDRESS MS. FARLEY'S REQUEST. A STUDY SESSION WAS SET FOR SEPTEMBER 9, 2019 @ 6:00 P.M. TOWN MANAGER ROBINSON WILL ASSEMBLE ALL DATA SUBMITTED OVER THE TWO YEAR PERIOD TO PREPARE FOR THE STUDY SESSION. MARSHAL PATTERSON WILL ASSEMBLE HIS DATA ON TRAPPING AND NEUTERING TO PRESENT AT THIS STUDY SESSION.

5. MAYOR'S REPORT ON CURRENT EVENTS. AT THIS TIME THE MAYOR MAY WISH TO CALL UPON THE COUNCIL OR STAFF FOR CURRENT EVENTS OR MONTHLY REPORTS.

- 6. STAFF REPORTS ON GOING ACTIVITIES WITH POSSIBLE DIRECTION BY COUNCIL.
 - A. TOWN MANAGER ROBINSON RESPONDED TO AARON SHRIEBERS REQUEST TO HAVE ONLINE BILLING AVAILABLE. COST TO TOWN WOULD BE; \$5,000.00 TO SET UP IN CURRENT SOFTWARE SYSTEM, 1.55% FOR CREDIT AND .29% FOR DEBIT, .19 CENT TRANSACTION FEE AND \$3.95 PER MONTH BILLING FEE. OUR SOFTWARE COMPANY WOULD CHARGE \$75.00 PER MONTH FOR SOFTWARE ADDITION. ROBINSON STATED THAT THERE IS NO MONEY IN THE BUDGET, OR, WE COULD RAISE RATES ACCORDINGLY. NO ACTION TAKEN.
 - B. POLICE REPORT. MARSHAL PATTERSON RESPONDED TO MS. FARLEY'S REQUEST FOR CAT ORDINANCE, AND SAID THAT A LOT HAD BEEN ACCOMPLISHED OVER THE LAST SEVEN MONTHS TO ABATE THE CAT POPULATION.

 MARSHAL PATTERSON DISCUSSED THE NEW STATIONARY TRAFFIC MONITOR ON HARSHAW ROAD AND EXPLAINED EVEN THOUGH IT WAS NOT DISPLAYING, IT WAS STILL COLLECTING TRAFFIC DATA. HE SHARED THE DATA WITH THE COUNCIL, AND ANNOUNCED IT WAS NOW LIVE. THE MARSHAL ALSO REPORTED A SUICIDE CALL HE RESPONDED TO AT A SPEED RATE OF 104 MPH ON 82 IN PURSUIT OF THE SUSPECTED PERSON, AND CAUGHT UP WITH THEM 1/4 MILE FROM LAKE PATAGONIA STATE PARK GATE. HE WAS ABLE TO APPREHEND WITHOUT INCIDENT, AND TRANSPORTED INDIVIDUAL TO PIMA COUNTY HEALTH FACILITY. DISCUSSION FOLLOWED WITH REGARD TO OFFICERS PROCEDURE IN USING LIGHTS AND SIRENS.

- C. PLANNING AND DEVELOPMENT MATTERS. COUNCILWOMAN MURRIETTA DEFERRED TO CHAIRPERSON TODD NORTON. MR. NORTON REPORTED THAT ALL COMMITTEE MEMBERS HAD A COPY OF THE POWERS AND DUTIES OF SAID COMMITTEE. THEY WERE ALL FAMILIARIZING THEMSELVES WITH THEIR NEW INFORMATION. HE ALSO SAID THE COMMITTEE HAD MOVED TO REQUEST THE COUNCIL TO CONSIDER PUTTING A CEILING OF 7 MEMBERS ON THE P & D COMMITTEE. HE ADDED THAT JERRY ISAAC, ONE OF THE COMMITTEE MEMBERS, WAS RESEARCHING THE LANGUAGE IN OUR TOWN PLAN TO MAKE RECOMMENDATIONS TO THE COUNCIL ON POSSIBLE CHANGES.

DISCUSSION: A LIVELY DISCUSSION BETWEEN COUNCIL MEMBERS REIBSLAGER & FINCH ABOUT THE TOWN TRIMMING TREES IN OUR RIGHT OF WAYS AND CHARGING FOR IT, VERSES TRIMMING THE TREES AS A CHARGED SERVICE TO THOSE TOWN PEOPLE WHO WOULD RATHER KEEP THE MONEY IN THE TOWN FOR THAT SERVICE. COUNCIL MEMBER FINCH SAID THE TOWN IS NOT IN THE TREE TRIMMING BUSINESS AND SHOULD NOT COMPETE WITH PRIVATE ENTERPRISE. AFTER THE DISCUSSION, MAYOR WOOD ASKED TOWN MANAGER ROBINSON TO RESEARCH THE LOCAL TREE TRIMMING BUSINESSES, TO DETERMINE A COMPETITIVE PRICE TO CHARGE TOWN PEOPLE FOR TRIMMING THEIR TREES IN OUR RIGHT OF WAYS.
