PUBLIC HEARINGS ON USE PERMITS

FOR JOSE DELGADO TO BUILD A TWO-STORY DUPLEX (1,389 SQ FT PER UNIT) ON PARCEL NO. 106-35-010B LOCATED AT 273 SMELTER AVE. PATAGONIA AZ.

Arturo Vazquez, Jose Delgado's architect, presented the duplex proposal. The project conforms to all Town building regulations and includes two off street parking spaces for each unit. Mr. Vazquez also explained the plan to move rain water through the property on either side of the buildings towards McKeown.

Neighbors expressed concerns about parking management and availability in the narrow dead-end alley, as well as emergency vehicle access. One neighbor was concerned about access for his motor home. A description of the exact location of the property line on Smelter was uncertain in terms of identifiable

landmarks, and the legal description will be checked. There was also discussion concerning increased housing density on smaller lots.

A motion was made by Steve Finch, and seconded by Georgette Larrouy to recommend further action by the Town Council on this use permit application with the stipulations that two parking places for each unit be included as well as a detailed plan for the flow of rainwater through the property toward McKeown.
